Myth #1 BUSINESSES OPPOSE TCI, AND DO NOT WANT TO CAP TRANSPORTATION POLLUTION

FACT #1 In a letter to Governor Ned Lamont, over 80 employers expressed support for TCI. This list included companies such as IKEA, Lyft, Nestle, Unilever, and DHL. Many businesses are actively trying to become more sustainable, and TCI would improve the sustainability of supply chains for all companies that operate in Connecticut. TCI is a market-based solution to air pollution that encourages the private sector to reduce its pollution.


Myth #2 CONNECTICUT RESIDENTS DO NOT SUPPORT TCI.

FACT #2 An overwhelming majority of Connecticut residents support TCI, and view it as essential to the economic recovery from COVID. According to a <u>recent poll</u>, seven out of ten voters support the TCI. Transportation is vital to our state's economy. The TCI would improve our transportation infrastructure and ensure that it is resilient to the effects of climate change.

Myth #3TCI IS A GAS TAX ON CONNECTICUT
RESIDENTS.FACT #3TCI is a cap on polluting emissions from
transportation. This cap drives investment in
cleaner vehicles, more reliable and convenient







transit, and improved transportation infrastructure by requiring companies that sell transportation fuel into the Connecticut to hold emissions allowances.



Myth #4 CONNECTICUT WILL CONTINUE TO EXPERIENCE A DECLINE IN TRANSPORTATION FUNDING.

FACT #4The TCI will generate additional investment
for Connecticut's transportation system.
Connecticut will also be better able to
leverage federal funding to improve our

STATES HAVE REFUSED TO JOIN TCI.

Massachusetts, Rhode Island, and the District of Columbia have joined with Connecticut in leading the way to implement the program. Eight additional states have formally committed to working towards adoption of the program on timelines necessitated by their particular circumstances. All of these jurisdictions are committed to working together to address a problem that impacts all of our communities. States that have implemented the program receive all of the benefits and each state has full control over the specific investments that it makes.





Myth #6	TCI WILL NOT HELP CONNECTICUT'S Environment.	
FACT #6	40% of Connecticut's carbon dioxide pollution comes from the transportation sector. TCI would significantly reduce the pollution that the transportation sector produces. This	
	would guarantee that individuals would enjoy a cleaner environment that has significantly less air pollution. Connecticut does experience a geographical problem, whereby pollution from other states moves into our state. However, Connecticut can take responsibility for its own pollution and our state can become more sustainable and healthier to live.	
Myth #7	TCI WILL NOT IMPROVE OUR AIR QUALITY AND PUBLIC HEALTH.	
	Researchers at the <u>Harvard School of Public</u> <u>Health</u> estimate that TCI would avoid over 300	
FACT #7	deaths per year , and prevent thousands of children from having asthma-related problems in our region. This would halp families save on	
	in our region. This would help families save on medical costs. Automobiles emit various pollutants, such as carbon monoxide, volatile	
	organic compounds, and particulate matter that are known to cause lung and breathing	
	problems. With carbon emissions capped at a certain level, these amounts of pollutants would be reduced in the air that we breathe. Our families would be able to live in healthier communities.
